It is hereby notified for general information that two (02) nos. masonry structure building having CGI Sheet roof covering shall be sold through inviting Public Auction (Sealed Bid) on **05.07.2024** by the Registrar, Uttar Banga Krishi Viswavidyalaya, Pundibari, Coochbehar from 2.30p.m at the office of the Registrar, Uttar Banga Krishi Viswavidyalaya, Pundibari, Coochbehar among the Outside Bonafide Contractors / Firms for the works as mentioned below by issuing this Bid / Auction notice. The willing participants are requested to attend in the office of the Registrar, Uttar Banga Krishi Viswavidyalaya, Pundibari, Coochbehar on **05.07.2024 before 2.30p.m** to quote their rates for the works as mentioned above with valid Income Tax, Professional Tax, GST, Pan Card, Trade Licence certificates. Successful bidder shall have to deposit the entire bid value in the form of Bank draft from any nationalized bank in favour of the Uttar Banga Krishi Viswavidyalaya payable at Coochbehar or through any negotiable fund transfer procedure as per rule within 7 (seven) days of receipt of acceptance cum Work Order. In case of failure of the same, the bid will be cancelled and the materials will be resold through another public auction. The Registrar, Uttar Banga Krishi Viswavidyalaya, Pundibari, Coochbehar reserves the right to accept or reject any offer.

1. Scope of Work and Description of the Structures to be demolished:

2 (two) nos. of single storey structure (Size of Structure-I: 11.0 m x 5.4 mtr x 2.6 mtr and size of Structure-II: 7.5 mtr x 6.6 mtr x 2.6 mtr + 11.0 mtr x 4.0 mtr x 2.6 mtr) with CGI sheet roofing fitted in wooden / steel truss resting on 250 mm thick load bearing brick wall + 125 mm thick brick partition wall. The defunct structures are to be demolished and uprooted from the foundation base (beneath ground level up to embedment depth) and the debris are to be removed from the work site by the vendor at his own cost and responsibility. Debris obtained from demolition should be disposed of outside the campus area in consultation with the University Engineer (Actg.) / Development Officer, UBKV. Any excavation if required to be done shall have to be refilled with good earth and levelled to existing ground level. The University shall not bear any cost or provide any machinery / implements for executing the dismantling work.

2. The interested parties may visit the site on any day between during 11.00 am to 2.00 pm .to assess the extent of work to be done with intimation to the University Engineer (Actg.), Works Department/ Development Officer of UBKV.

3. The University authority shall not be held responsible for any injury of the workers during the demolishing work and shall not pay any compensation for such injury/ incidents.

4. The successful bidder shall have to complete the entire work within 30 (thirty) days from the date of issuance of work order.

5. The University authority reserves the right to accept or reject any or all tenders without assigning any reasons.

6. If any dispute arises, the decision of the University authority shall be final and binding on the part of responsive bidders.
